



What is the Jewish National Fund (JNF)?

The JNF was created in 1901 to purchase land in historic Palestine **for Jewish-only settlement**. It has since obtained large swaths of territory through **exploitative land sales** and from **often-violent, forced removals of Palestinians from their lands**. The JNF now owns 13% of all lands in Israel, on which it has built **communities reserved for Jews only**, and forests intended to **conceal destroyed Palestinian villages**.

JNF Canada raises millions of dollars for JNF projects in Palestine-Israel each year. In 2016 alone, JNF Canada raised **nearly \$30 million**. These funds are tax-deductible, and are therefore **subsidized by our tax dollars**.
